Requirements of Board membership include:

1. Commitment to the work and mission of the organization;
2. Willingness to serve on focus teams and/or committees;
3. Attendance at Board meetings;
4. Attendance at MN Ag EXPO and the annual MCGA business meeting;
5. Support of special events;
6. Support of, and participation in, fund-raising events and external meetings;
7. Knowledge and skills in one or more areas of Board governance: policy, finance, programs, personnel and advocacy;
8. Membership in MCGA; and
9. Working to understand the interests of MCGA members as a whole

Term of Service

Directors are elected by the membership at the annual business meeting. Directors serve for a three-year term and may be elected for up to three consecutive terms.

General Duties

A Director is fully informed on organizational matters; comes prepared for meetings; and participates in the Board's deliberations and decisions in matters of policy, finance, programs, personnel and advocacy.

The Director must:

1. Participate in development of MN Corn organizations' strategic plan and plan reviews;
2. Participate in development, approval and monitoring of board policies;
3. Review bylaws and policies and recommend bylaw changes;
4. Review the Board's structure, approve changes, and prepare necessary bylaw amendments;
5. Participate annually in the development and approval of the organization's budget;
6. Approve hiring and release of executive director including his/her employment contract;
7. Support and participate in evaluating the executive director; and
8. Assist in developing and maintaining positive relations among the Board-Council, teams and committees, staff members, county affiliates, and others to enhance MCGA's mission.

Evaluation

The board's performance may be evaluated annually. At some point in the future, each Director's performance may be evaluated based on the performance of assigned Board requirements and duties.
